An Ordinance amending Ordinance No. 1080 to allow individual City of Harahan Council Members to place items of business on the agendas of regular and/or special meetings of the City of Harahan.

WHEREAS, the City Council holds regular and/or special meetings for the City of Harahan's business; and

WHEREAS, it is in the best interest of the City of Harahan to allow individual members of the Harahan City Council to place items of business on the agenda of city council meetings in order to transact the orderly business of the City of Harahan.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Harahan, State of Louisiana, acting as the governing authority of said City that:

**SECTION 1.** Any member of the Harahan City Council shall be allowed to place items on the agenda of a regular meeting if received no later than 4:30 p.m. on the Friday immediately preceding the regular meeting.

**SECTION 2.** Any member of the Harahan City Council shall be allowed to place items on the agenda of a special meeting if received no later than 25 hours prior to the time fixed for the special meeting to permit sufficient time to satisfy the requirements set forth in La. R.S. 42:19.

**SECTION 3.** The severability and repeal clause as referenced in Ordinance No. 1566 is incorporated into this Ordinance.
