Mayor Miceli said her budget offered and funded an additional policeman and an additional fireman.

Eric Chatelain, Colonial Club Dr. said the budget needs to pass – you can amend it every month. If you took the city out of the \$1.2 million dollar deficit in two years – you have extra money – work it out

Chief Tim Walker – I presented a budget to the council – The payroll expenses are included.
