# City of Harahan 6437 Jefferson Highway Mayor and Harahan City Council Council Meeting Minutes February 22, 2018

Mayor Miceli opened the Meeting 7:34 pm.

The City Clerk led the pledge of allegiance.

The City Clerk called the roll.

#### **MAYOR'S COMMENTS:**

The Mayor mentioned the Florida shooting incident and reminded everyone of their responsibility to report anything out of the ordinary – she asked for a moment of silence for the victims and their families. She also updated the status of the Pump Station 8 project. 5 bids came in and the contract was awarded to Fleming Construction Co. with a bid of \$124,410. Work will be started the week of February 26th to be completed by May, 2018. Sewer repairs by Gulf Coast Underground have several back yard repairs still to be done. Restoration of the yards will be completed by March, 2018, if weather permits. Street resurfacing in the VFW area - design completion is set for March with road work starting in June using Jeff. Parish Annual Asphalt & Concrete to perform the work. Pump Station 6 - rehabilitation and rerouting will relieve 40% of the sewerage load on Station 8 - design work is on schedule to be complete in April, with bidding in May – and construction is scheduled to start in June to be completed in late 2018. Finish date is dependent on weather. The streetscaping grant from DOTD for sidewalk improvement brings in \$338,763 in grant money for the proposed projects of curb ramps, crosswalk refurbishment and sidewalks along Jefferson Hwy. Won't address all areas – but is first step to make pedestrians and cyclists safer. Preliminary design is ready.

## **SPECIAL PRESENTATIONS**

1. Darlene Schwartz, Community Liaison – she reminded that property taxes are now delinquent – she urged everyone to pay them before March 1<sup>st</sup> to avoid further penalties. Drug enforcement Take Back Day will be April 28<sup>th</sup>. Regular locations will be open from 10 am to 2 pm. She thanked everyone for the support for her and family on the death of her mother.

Mayor Miceli told Ms. Schwartz that she and the administration is there for her.

2. Current State of the Harahan Police Department

Chief Walker said he spoke to the Mayor about Incode – but is still complaining about it. He said the Mayor of Mandeville had his financials on his phone. He is still complaining about not getting timely financials. He asked the Mayor about calling a car dealership – he apologized to Councilman Benton saying he bought 6 machine guns instead of the 4. He said it was primarily funding from Jefferson Parish used to purchase the ammunition, guns and cars. He questioned the pension system for the police dept. He asked about the auditing firm being used. He asked for all payments for health insurance from the insurance company for the police dept. He wants the figures that were paid. Crimestoppers says to lock your car – they notified the area around Harahan School about the children's Mardi Gras parade and found 9 cars unlocked.

# PROPOSED ORDINANCE NO. 2017-39 (Deferred 1/25/2018)

An Ordinance amending Ordinance No. 1822, the annual Budget of Revenues and Expenditures for the Fiscal Year ending December 31, 2017 for the City of Harahan, Louisiana. (Harahan Police Department)

**ORDINANCE DEFERRED** 

#### **PROPOSED ORDINANCE NO. 2018-1**

An Ordinance relating to asphalt repairs around the City of Harahan to be performed during the Fiscal Year ending December 31, 2018.

This Ordinance was proposed by Councilman Benton and seconded by Councilman Johnston.

Open Hearing - No one spoke.

Council Discussion – Councilman Johnston said there is not enough information – he wants a list of streets to be done besides Elodie & Heebe. He wants to know the costs of the curbs, the sidewalks and the streets itemized.

Mayor Miceli said that there are areas throughout the city that need to be repaired because patch work is not enough. Not having money in the budget hinders the day to day operations and repairs in the city.

Councilman Wheeler said they asked Mr. Hoppmeyer about the \$100,000 for streets and for the \$30,000 for drainage and did not receive it. They don't know how much they have because they don't have the run sheets.

Mayor Miceli said this is the capital budget to take care of citizen's complaints and the money is for longer than 1 year. State law says we should have a comprehensive budget for General Fund & Capital Fund – but Harahan has no capital fund budget.

Councilman Baudier says they are responsible for the budget numbers – he can't sign off on that – you are asking for our help but we only have a guess of what we need.

Councilman Johnston said that he wants to know where we are at and what other streets are on the list.

Mayor Miceli said that Mr. Hoppmeyer told them the price per foot for repairs. She asked they meet with Mr. Hoppmeyer before the next meeting. She will ask when Mr. Hoppmeyer is available and let them know.

Councilman Wheeler again asked for the run sheets.

Mayor Miceli asked the City Clerk to get in touch with Mr. Hoppmeyer.

Councilman Wheeler and Councilman Johnston wants an itemized list of all needed repairs.

A motion was made by Councilman Johnston and seconded by Councilman Wheeler to defer the vote until March.

The Mayor called for the vote, it was as follows:

## **ORDINANCE DEFERRED**

Councilman Baudier stated for the record that he will not vote on miscellaneous items – he wants itemized lists.

Councilman Wheeler - wants the streets that are dug up to be fixed first.

Mayor Miceli – said the council can research the streets that need to be done and amend the ordinance to include them.

Councilman Johnston – streets that are torn up – will they be included with the sewerage repairs or will they be in this ordinance. He noticed that they have patched some streets but some are sinking.

Mayor Miceli – it would be very helpful if you would let the city know about that so they don't release the contractor before the city is satisfied with the job.

#### **PROPOSED ORDINANCE NO. 2018-2**

An Ordinance relating to drainage maintenance around the City of Harahan to be performed during the Fiscal Year ending December 31, 2018.

This ordinance was proposed by Councilman Benton and seconded by Councilman Johnston.

The City Clerk read the ordinance by title only.

Mayor Miceli read a statement from Calvin Hoppmeyer – this will allow the city to effect needed repairs for the drainage system. A drainage maintenance program is mandated – this is in addition to the money supplied by the Parish. Prior to storms, the parish equipment may not be used at that time – we want to start this now. Open Hearing - Jason Bruzik, Stoneleigh – he asked about the contracts – will they be submitted to the council before you sign them? You have not presented the contracts. Harahan Law says you have to do that.

Council Discussion – Councilman Johnston said that he and Councilman Wheeler met with Councilman Paul Johnston to get the truck from the Parish and asked where is the \$30,000 going – the parish truck is doing the work.

A motion to proceed with the vote was made by Councilman Johnston seconded by Councilman Baudier.

Councilman Johnston explained that the majority of work will be done for free by the Parish - \$30,000 is too much – Jefferson parish is doing most of the work.

# 1. Civil Service Board Appointment

Mayor Miceli said there are two appointments to be considered. One from the Loyola list and Glenn Landry has reconsidered his resignation. She asked for nominations from the council. She received none.

Mayor Miceli nominated Glenn Landry for re-instatement.

A motion was made by Councilman Baudier to amend the agenda to add "Mayor Pro Tem Comments" under Old Business seconded by Councilman Johnston.

Councilman Baudier posed a question to Mr. Buras concerning the council writing laws that hinder the Mayor from doing her job. They wrote a law giving the police dept. access to Incode and she hasn't followed the law.

Mr. Buras said that access for all depts. includes payroll and personnel files – if they are specific to perform his functions as an elected Police Chief he can get that. He said I know you want him to have access to all depts. with read only – but some information should not be open to access. Financial information is pretty much public record but to give total read only access – that's not a good idea.

Mayor Miceli said that the chief's secretary came and explained what she wanted and she asked the chief to confirm that.

Mr. Buras – said that "address the council" is to speak to the council, but it is not an inquisition of the Mayor. The Lawrason Act does not fit Harahan any more. He is still waiting on an Attorney General's opinion about the contracts – and he does not feel that the Mayor has to do that – every paycheck is a contract. This is not what the Lawrason Act intended.

Chief Walker said they are not looking for personnel files – personnel files are not in Incode – this is smoke and mirrors – he wants financials to see what he is being charged for – we were charged for Mr. Buras to attend the council meeting.

Councilman Baudier asked Chief Walker whether the personnel information was in Incode. He said Mr. Buras said to give him access.

Mayor Miceli said she spoke to the Chief today and asked if what they did to give him access to Incode was working. Last year she called Daul Insurance and they offered email access to see his dept.'s costs. This would provide information to you.

Chief Walker said you wanted the police dept. to be responsible as an HR dept. – you wanted us to enroll our officers.

Mayor Miceli said you could get access by Daul – it's as much as you want to do.

Chief Walker said this is about Incode – they came to the office and when they left – his access was cut off.

Councilman Wheeler screamed at the Mayor to give him the access and let's move on. Councilman Baudier asked for a list of private information on Incode.

Councilman Wheeler said just give it to him.

Mr. Buras said he does not know what Incode looks like and what information it contains. He will look into it as a lawyer and give a legal opinion.

Councilman Johnston said he just wants access back.

Councilman Wheeler said the denial of access was done out of spite.

Chief Walker asked for an honest answer why this was done. The Incode representative came to his office and when he left – they no longer had access.

Mayor Miceli said there were major projects done to improve the Incode system to correct the mistakes of the past. She thinks access was turned on already but she's asking that you let me know if it works.

Councilman Baudier asked Mr. Buras to look into the Attorney General Opinion 11-00-84

Mr. Buras asked that he send it to him.

## **NEW BUSINESS**

1. Appointments to the Fire Dept. Advisory Board.

Chief St. Cyr said he wanted to appoint Chris Henderson & Kelly Roche as his nominees on the board.

Councilman Wheeler offered a motion seconded by Councilman Johnston to defer the council's nominations to the March meeting.
