REQUIREMENTS FOR PEDDLERS PERMIT

- 1. LEASE OR NOTARIZED LETTER OR PERMISSION FROM PROPERTY OWNER.**
- 2. COPY OF COMPREHENSIVE GENERAL LIABILITY POLICY (MINIMUM \$50,000) WITH FOOD PRODUCT ENDORSEMENT (POLICY MUST INDICATE ADDRESS OF THE PEDDLERS STAND / TRUCK). THIS REQUIREMENT APPLIES ONLY TO PEDDLER OF FOOD PRODUCTS.**
- 3. BOARD OF HEALTH APPROVAL (FOR FOOD PRODUCTS)**
- 4. ALL PEDDLERS ARE REQUIRED TO PROVIDE AN ADDITIONAL PARKING SPACE (HARD AND IMPERVIOUS) FOR EACH 200 SQUARE FEET OF SUCH ESTABLISH AREA. (A PLOT PLAN SHOWING LOCATION OF STAND OR TRUCK & ALL REQUIRED OFFSTREET PARKING AND A CURRENT SURVEY SHOWING ALL IMPROVEMENTS SO PARKING CAN BE EVALUATED.)**
- 5. CITY OF HARAHAH PEDDLERS LICENSE. (\$200.00)**
- 6. PERMITS MUST BE RENEWED ANNUALLY.**
- 7. MAXIMUM SIZE SIGN ALLOWED IS 6 SQUARE FEET.**
- 8. ALL PEDDLERS SHALL ONLY BE LOCATED ON PRIVATE PROPERTY.**
- 9. PEDDLER CAN ONLY BE ALLOWED IN ZONING DISTRICTS WHICH ALLOWS RETAIL SALES.**

On a motion by Alderman Ranatza, seconded by Alderman Picone, the following ordinance was offered:

ORDINANCE NO. 1045

An Ordinance to amend Chapter 11, Article II, of the Harahan Municipal Code to revise the fee required to obtain a peddlers license.

BE IT ORDAINED BY THE BOARD OF ALDERMEN OF THE CITY OF HARAHAN, ACTING AS THE GOVERNING AUTHORITY OF SAID CITY THAT:

SECTION 1. That the Harahan Municipal Code be amended by revising Chapter 11, Article II, License Taxes, Division 2, Occupational License Tax, Section 11-42, Levy; amount, (b) to set the fee required to obtain a Peddlers' License as provided by LRS 47:359C.

SECTION 2. PEDDLERS AND ITINERANT VENDORS. That there is hereby imposed and levied an annual license tax on all peddlers, hawkers, itinerant vendors and every person who displays samples models, goods, wares, or merchandise on a temporary basis in any hotel, motel, store, storehouse, house, vehicle, or any other place, for the purpose of securing orders for the retail sale of such goods, wares, or the like kind or quality, either for immediate or future delivery shall obtain a license based on a fee of two hundred dollars (\$200.00) provided that an itinerant vendor of agricultural products purchased directly from farmers or an itinerant vendor of seafood products who has either harvested the seafood himself or has purchased the seafood directly from commercial fishermen or shrimpers shall obtain a license based on a flat fee of one hundred dollars (\$100.00).

SECTION 3. All license taxes levied herein shall be due and payable on January 1st of each year and all unpaid license taxes shall become delinquent on March 1st. The collection of delinquent accounts shall be enforced in accordance with L.R.S. 47:1601 and 47:1602.

SECTION 4. All ordinances in conflict herewith are hereby repealed.

SECTION 5. Should any provision of this ordinance, or the application thereof, be held invalid, such invalidity shall not affect the validity of the remaining portions of this ordinance.
